Appointment - Agricultural Land Preservation Advisory Board - Robert W. Miller, Sr.

WHEREAS, pursuant to Maryland Annotated Code, Agriculture Article, Subtitle 5. Maryland
Agricultural Land Preservation Foundation, Section 2-504.1, an Agricultural Preservation Advisory Board shall
be appointed by the elected body by each county, which has productive agricultural land; and
WHEREAS, the Agricultural Preservation Advisory Board shall consist of five members, at least three of
whom shall be owner-operators of commercial farms who earn fifty percent or more of their income from
farming; and
WHEREAS, each member of the Agricultural Preservation Advisory Board shall be appointed for a term
of office of five years, and no member shall serve for more than two consecutive full terms; and
WHEREAS, the duties of the Agricultural Preservation Advisory Board shall be to advise the county
governing body with respect to the establishment of agricultural districts and the approval of purchases of
easements by the Foundation within the county, to review the status of agricultural districts and land under
easement, to advise the Foundation concerning county priorities for agricultural preservation, to approve
applications by the county for certification, to promote preservation of agriculture within the county; and to
meet at least annually with forest conservation district boards in order to work cooperatively to encourage the
promotion and retention of farmland and woodland in their jurisdictions; and
WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County Executive
shall appoint all members of boards and commissions, subject to confirmation by the Council; and
WHEREAS, the County Executive has reappointed Robert W. Miller, Sr. to serve on the Agricultural
Land Preservation Advisory board term which is to expire August 15, 2021.
NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,
MARYLAND confirms the reappointment by the County Executive of Robert W. Miller, Sr. to serve on the
Agricultural Land Preservation Advisory board term which is to expire August 15, 2021.
AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that all
provisions of this Resolution shall take effect on the date that the Resolution is adopted by the Council.
