Title of Resolution: Supplemental Appropriation - Public Library - Elkton Parking Lot

Synopsis: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2017 in order to provide the Cecil County Public Library's budget within the General Fund expenditure appropriation authority with \$23,967 of unexpended FY2016 expenditure authority to be carried forward, allowing for the Elkton Parking Lot Improvement Project to be completed.

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2016, the County
2 Executive submitted a proposed budget to the County Council for Fiscal Year 2017; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2017; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2016, the
6 County Council adopted the budget for Fiscal Year 2017; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2017 General Fund Budget revenue
8 estimate for Cecil County to increase the amount of fund balance available by \$23,967; and to establish the
9 following amounts within the General Fund as follows:

- 10 a) To allow the Cecil County Public Library to carry forward \$23,967 in small capital project
11 expenditure authority to allow for the completion of the Elkton Parking Lot Improvement
12 Project.

13 **WHEREAS**, such appropriation is necessary to provide \$23,967 from fund balance for the General
14 Fund expenditures; and

15 **WHEREAS**, the Library and Cecil County Public Schools have been collaborating since January
16 synchronizing civic plans for the future connection of the two lots. This effort has resulted in the Library
17 having to re-engineer storm water management plans to accommodate the first row of parking which
18 straddles the Gilpin Manor and Library property line. The Library 's plans are currently in the Storm Water
19 Management approval process with Cecil Soil Conservation District and the Town of Elkton and anticipate
20 final approval in the first quarter of FY2017. The requested carryover funding will help cover the ongoing
21 cost for engineering and construction that will take place in FY2017.

22 **NOW THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
23 the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year 2017 is hereby
24 amended for the supplemental appropriation and by amending the Current Budget to appropriate the
25 carryover of \$23,967 in expenditure authority to allow the Elkton Parking Lot Improvement Project to be
26 completed using the funding allocated by the County, but not fully expended in FY2016.

27 **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by
28 the County Council of Cecil County, Maryland.
