**Title of Bill:** Compensation for County Council Members

**Synopsis:** An Act to enact a new Section of Chapter 21 County Council, to be titled Section 21-3 Compensation of County Members, of the Code of Cecil County, as amended; to set the compensation for County Council Members to \$27,000 as of December 3, 2018.

1           **WHEREAS**, pursuant to Section 10-302 of the Local Government Article of the Annotated Code of  
2 Maryland, a county may establish a commission to recommend the compensation and allowances for  
3 members of the county legislative body; and

4           **WHEREAS**, the commission may recommend an increase or decrease in the compensation and  
5 allowances for members of the county legislative body; and

6           **WHEREAS**, on receiving the recommendation, the county legislative body may reduce or reject the  
7 commission's recommendation, but may not increase any item; and

8           **WHEREAS**, any change in the compensation and allowances of members of the county legislative  
9 body shall be enacted by ordinance before the election for members of the next succeeding county  
10 legislative body and take effect only for the members of the next succeeding county legislative body; and

11           **WHEREAS**, the compensation or allowances for members of the county legislative body of a  
12 charter county may not be less than provided in the county charter; and

13           **WHEREAS**, pursuant to the Charter of Cecil County, Section 207 Compensation, each council  
14 member shall receive as compensation and allowances for the performance of public duties under this  
15 Charter the sum of not less than \$25,000 per year; and

16           **WHEREAS**, the County Council shall establish by ordinance a Compensation Review Commission  
17 every four years to review the Council's compensation and allowances in accordance with State law; and

18           **WHEREAS**, the County Council appointed a Compensation Review Commission by Resolution No.  
19 11-2016 on April 5, 2016 to review and recommend the compensation and allowances of the County  
20 Executive, County Council and Cecil County Sheriff; and

21           **WHEREAS**, the Compensation Review Commission presented their recommendations to the  
22 County Council on June 7, 2016; and

23           **WHEREAS**, it was the Commission's recommendation that the compensation of County Council  
24 Members be increased from \$25,000 per year to \$27,000 per year, an increase of \$2,000.

25           **NOW THEREFORE, BE IT ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that  
26 a new section of Chapter 21 County Council of the Code of Cecil County is hereby enacted to read as  
27 follows:

28 Section 21-3. Compensation of County Members

29 County Council Members will receive an annual salary of \$27,000 as of December 3, 2018.

30           **AND BE IT FURTHER ENACTED** by the County Council of Cecil County, Maryland, that this Act shall  
31 take effect 60 calendar days from the date it becomes law.
