2	structures require comprehensive regulations through the implementation of planning and zoning
3	controls, pursuant to Section 4-101 of the Land Use Article of the Annotated Code of Maryland; and
4	WHEREAS, the State provides that local governments shall implement planning and zoning
5	controls that are appropriate to improve or protect the general character and design of land and
6	improvements; and
7	WHEREAS, the County's legislative body shall adopt zoning regulations to promote health,
8	public safety and general welfare, pursuant to Section 4-202 of the Land Use Article of the Annotated
9	Code of Maryland; and
10	WHEREAS, the County's legislative body shall provide a manner in whick its zoning
11	regulations and boundaries of districts may be amended or repealed, pursuant to Section 4-203 of the
12	Land Use Article of the Annotated Code of Maryland; and
13	WHEREAS, an amendment to the Zoning Ordinance has been proposed and on July 18,
14	2016, the Planning Commission recommended approval of the proposed amendment.
15	NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
16	MARYLAND, that the proposed amendments to Article V, Part V, Section 96 Theater - Drive-in of the
17	Zoning Ordinance are here by adopted as follows:

18 Section 96. Theater - Drive-in

- 19 Theaters drive-in, open air theaters, and amphitheaters shall be permitted as Special Exceptions in the
- 20 NAR, SAR, LDR, BG and BI zones provided:
- 21 1. The picture face of the screen shall be so located that the picture will not be visible from adjacent roads and dwellings.
 - 2. The screen shall be setback not less than two hundred (200) feet from all property lines.
- 3. THE PROVISION OF FOOD, REFRESHMENTS, AND ENTERTAINMENT LIMITED 3 DAYS IN ANY
 NINETY (90) DAY PERIOD, WHETHER CONSECUTIVE OR NOT, MAY BE ALLOWED IN CONNECTION
 WITH SUCH USE.
- 4. THE ACCESS FOR THE USE IS LOCATED ON AN ARTERIAL OR COLLECTOR STREET AND NOT LOCATED

 ON A LOCAL STREET.

- 5. ALL OUTDOOR LIGHTING SHALL BE LOCATED, SHIELDED, LANDSCAPED, OR OTHERWISE BUFFERED

 SO THAT NO DIRECT LIGHT SHALL CONSTITUTE AN INTRUSION INTO ANY RESIDENTIAL AREA.
- 31 6. A BUFFERYARD MEETING THE C STANDARD OF APPENDIX B SHALL BE PROVIDED BETWEEN THE 32 USE AND ADJOINING RESIDENTIAL DEVELOPMENT.
- 7. THE PROPOSED SITE SHALL BE SUFFICIENT SIZE TO ACCOMMODATE THE USE WITHOUT AFFECTING
 ADJACENT LAND USES.
 - 8. AUTOMOBILE PARKING AREAS SHALL NOT BE CLOSER THAN FIFTY (50) FEET TO ANY ADJACENT RESIDENTIAL LOT.
