1	WHEREAS, pursuant to Md. Code Ann., Title 9, § 9-3211(B), State Government Article, there is a
2	Local Government Justice Reinvestment Commission (the "Commission"); and
3	WHEREAS, pursuant to Md. Code Ann., Title 9, § 9-3211(C), State Government Article, the
4	Commission shall advise the Justice Reinvestment Oversight Board (the "Board") on matters related to
5	legislation, regulations, rules, budgetary changes, and all other actions needed to implement the
6	recommendations of the Justice Reinvestment Coordinating Council as they relate to local governments,
7	make recommendations to the Board regarding grants to local governments from the Performance
8	Incentive Grant Fund, and create performance measures to assess the effectiveness of the grants; and
9	WHEREAS, pursuant to Md. Code Ann., Title 9, § 9-3211(D)., State Government Article, the
10	Commission consists of one member from each county appointed by the governing body of the county;
11	and
12	WHEREAS, pursuant to Md. Code Ann., Title 9, § 9-3211(E)(1), State Government Article, the term
13	of a member is four (4) years; and
14	WHEREAS, pursuant to Md. Code Ann., Title 9, § 9-3211(E)(2), State Government Article, the terms
15	of the members of the Commission are staggered as required by the terms provided for members of the
16	Commission on October 1, 2016; and
17	WHEREAS, pursuant to Md. Code Ann., Title 9, § 9-3211(E)(3), State Government Article, at the end
18	of a term, a member is eligible for reappointment and continues to serve until a successor is appointed
19	and qualifies; and
20	WHEREAS, the County Council has nominated Matthew Barrett, Circuit Court Administrator for
21	Cecil County, to serve as Cecil County's member to the Commission.
22	NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,
23	MARYLAND, appoints Matthew Barrett, Circuit Court Administrator for Cecil County, to serve as Cecil
24	County's member to the Local Government Justice Reinvestment Commission for a four year term to
25	begin on October 1, 2016.
26	AND BE IT FURTHER RESOLVED by the County Council of Cecil County that all provisions of the
27	Resolution shall take effect on the date the Resolution is adopted by the Council.
