**Title of Bill:** Compensation and Allowances for County Executive

Synopsis: An Act to enact a new Section of the Code of Cecil County to be titled Chapter 22, County Executive, and new section, 22-1 Compensation of County Executive, in order to set the compensation and allowances for County Executive to \$100,000 and eligibility for employee group insurance coverage, as of December 3, 2016.

## **Compensation and Allowances for County Executive**

1	<b>WHEREAS</b> , pursuant to Section 10-303 of the Local Government Article of the Annotated Code of
2	Maryland, the county may set the qualifications, term of office and compensation for the county
3	executive; and
4	WHEREAS, pursuant to Section 408(a) of the Charter of Cecil County, the Executive shall receive a
5	sum not to exceed \$98,000 per annum as compensation and allowances for the performance of public
6	duties; and
7	WHEREAS, the County Council shall establish by ordinance a Compensation Review Commission
8	every four years to review the Executive's compensation and allowances in accordance with State law;
9	and
10	WHEREAS, the County Council appointed a Compensation Review Commission by Resolution No.
11	11-2016 on April 5, 2016 to review and recommend the compensation and allowances of the County
12	Executive, County Council and Cecil County Sheriff; and
13	WHEREAS, the Compensation Review Commission presented their recommendations to the
14	County Council on June 7, 2016; and
15	WHEREAS, it was the Commission's recommendation that the compensation of the County
16	Executive be increased from \$98,000 per year to \$100,000 per year, an increase of \$2,000; and
17	WHEREAS, it was the Commission's recommendation that the County Executive be eligible for
18	employee group insurance coverage at the same terms and conditions as offered to County employees.
19	NOW THEREFORE, BE IT ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that
20	a new section of the Code of Cecil County to be titled Chapter 22. County Executive is hereby enacted to
21	read as follows:
22	Chapter 22. County Executive
23	Section 22-1. Compensation of County Executive
24	The County Executive will receive an annual salary of \$100,000 as of December 3, 2016. The County
25	Executive is eligible for employee group insurance coverage under the same terms and conditions as that
26	offered to other County employees.
27	AND BE IT FURTHER ENACTED by the County Council of Cecil County, Maryland, that this Act shall

take effect 60 calendar days from the date it becomes law.
