Synopsis: A Bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2017, to transfer the bond expenditure authority in the amount of \$61,011 within the Facilities Maintenance General Capital Projects Fund from three completed projects (Courthouse Roof Replacement(58023), Construct Courthouse Sally Port(58024) & Courthouse Phase II Renovation Projects(58022); and utilize the unspent bond funds to further the project to renovate the Historical Society and Arts Council(58040).

Budget Transfer - Capital Budget - Historical Society and Arts Council

WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2016, the
County Executive submitted a proposed budget to the County Council for Fiscal Year 2017; and
WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council
held public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2017; and

WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2016,

the County Council adopted the budget for Fiscal Year 2017; and

WHEREAS, the County Executive is revising the Fiscal Year 2017 Facilities Maintenance General Capital Projects Fund Budget to transfer bond revenue and expenditure authority from three completed capital projects as follows:

- a) Courthouse Roof Replacement remaining bond funds of \$6,722; and
- b) Construct Courthouse Sally Port remaining bond funds of \$43,910; and
- c) Courthouse Phase II Renovations remaining bond funds of \$10,379.

WHEREAS, the Capital Improvement Program included the approved project to renovate the Historical Society Building including the windows and roof of the facility. The approved Engineering and construction funding for the project is \$180,000. The current estimates based on the actual deterioration found within this historic structure result in a total project estimate cost of \$234,000; and

WHEREAS, Section 506 of the Charter of Cecil County requires that no final budget action may be taken by the County Council until after public hearing or hearings have been held in open public session; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,

- MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year 2017 is hereby amended to transfer \$61,011 of bond expenditure authority within the Facilities Maintenance General Capital Project's Fund from three completed Courthouse projects to the Historical
