1           **WHEREAS**, a Local Development Council shall be established in each geographic area where a  
2 video lottery facility is located, pursuant to Maryland Annotated Code, State Government Article, Section  
3 9-1A-31 and

4           **WHEREAS**, a Local Development Council shall consist of fifteen members appointed by the chief  
5 executive of the county in which the local development council is located; and

6           **WHEREAS**, the Local Development Council shall consist of fifteen members appointed by the chief  
7 Executive of the county in consultation with the Senators and Delegates who represent the communities  
8 surrounding the facility and the county council; and

9           **WHEREAS**, the Local Development Council shall include one Senator and two (2) Delegates who  
10 represents the district where the facility is located, one representative of the video lottery operation  
11 licensee, seven (7) residents of the communities in immediate proximity to the facility, and four (4)  
12 representatives of businesses or institutions located in the immediate proximity of the facility; and

13           **WHEREAS**, a county shall develop a multiyear plan for the expenditure of the local impact grant  
14 funds for services and improvements, in consultation with the Local Development Council; and

15           **WHEREAS**, the Local Development Council will review and comment on the multiyear plan before  
16 adopting the plan or expending any grant funds; and

17           **WHEREAS**, the Local Development Council will advise the county on the impact of the facility on  
18 the communities and the needs and priorities of the communities in immediate proximity to the facility;  
19 and

20           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
21 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;


23           **WHEREAS**, the County Executive has reappointed Russell Milam to serve on the Local  
24 Development Council for a four (4) year term which is to expire in August 16, 2020.

25           **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**  
26 **MARYLAND**, confirms the reappointment by the County Executive of Russell Milam to serve on the Local  
27 Development Council for a four (4) year term which is to expire in August 16, 2020.

28           **AND, BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by  
29 the County Council of Cecil County, Maryland.
