1 **WHEREAS**, Pursuant to Article II, Section 191-6A of the Code of Cecil County, the County Executive
2 shall appoint a board which shall be known as the "Board of Electrical Examiners," consisting of seven persons
3 for the purpose of examining the qualifications and capabilities of all persons who are engaged in, or desire to
4 engage in the business of master electrician or limited electrician as defined in this chapter; and

5 **WHEREAS**, Pursuant to Chapter 191, Article II, Section 191-10 of the Code of Cecil County, the Board of
6 Electrical Examiners shall advise the County and aid in the supervision and enforcement of any rule or
7 regulation adopted pursuant to the authority of the code and Maryland law; and the Board shall act as an
8 appeals board concerning matters arising under the adopted code and any licensing provisions; and

9 **WHEREAS**, Pursuant to Article II, Section 191-6B of the Code of Cecil County, the County Executive
10 shall appoint seven members, all being residents of Cecil County, and so appointed shall consist of at least four
11 persons who are master electricians, and one member shall be a person whose name appears on a list of
12 candidates recommended by the Cecil County Fireman's Association, if submitted; and

13 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
14 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
15 and

16 **WHEREAS**, the County Executive has reappointed Joshua A. Huegel to serve a 3 year term to
17 expire September 20, 2019.

18 **NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County confirms the
19 reappointment of Joshua A. Huegel to the Electrical Examiners Board for a three year term to expire on
20 September 20, 2019.

21 **AND, BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by
22 the County Council of Cecil County, Maryland.
