Application was presented for construction of a non-profit canine rescue on easement property currently owned by Bohemia Stables. Land is in process of transfer to effectuate the will of Mrs. Richard C. DuPont. The use of the land has recently been approved by the MALPF Board of Trustees. New construction must be included inside of a one (1) acre envelope that includes a pre-existing dwelling. Land use allowed by the County Zoning Ordinance as it is a non-profit organization.
