1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2016,  
2 the County Executive submitted a proposed budget to the County Council for Fiscal Year 2017; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council  
4 held public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2017; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2016,  
6 the County Council adopted the budget for Fiscal Year 2017; and

7           **WHEREAS**; Contracts, leases and other obligations that provide for payment of funds at a  
8 time beyond the end of the fiscal year in which these contracts are made are permitted, provided that the  
9 nature of these transactions reasonably require the making of these contracts, leases and other  
10 obligations, pursuant to Section 515 of the Charter of Cecil County ; and

11           **WHEREAS**, the County Council shall authorize by law any contract, lease, or other  
12 obligation in excess of \$20,000 that require the payment of funds from the appropriation of a later fiscal  
13 year, pursuant to Section 515 of the Charter of Cecil County; and

14           **WHEREAS**, the Department of Finance/Purchasing on behalf of the Department of Public  
15 Works solicited for a Global Positioning System, GPS, to track the location of their vehicles, which also  
16 included vehicles of the Cecil Transit System, and

17           **WHEREAS**, the solicitation includes providing GenX5P Verizon CDMA with backup battery  
18 and power harnesses to 116 vehicles; and

19           **WHEREAS**, RASTRAC Vehicle Tracking Service of Austin, Texas, was selected as the desired  
20 proposer; and

21           **WHEREAS**, the County wishes to enter into a 60 month contract for RVTS Automatic  
22 Vehicle Location, AVL, services for a service period of sixty months beginning on November 1, 2016 and  
23 ending on September 30, 2021 at a monthly cost of \$25.33 per vehicle for 116 vehicles; and

24           **WHEREAS**, the County accepts the contract terms that allow the agreement to be renewed  
25 annually at the option of Cecil County; and

26           **WHEREAS**, the contract agreement will provide payment from County funds in Fiscal Years  
27 2017, 2018, 2019, 2020, 2021 and 2022; and

28           **WHEREAS**, because the contract agreement requires the payment of funds from  
29 appropriations in later fiscal years, the County Council is required to approve this multi-year agreement,  
30 pursuant to Section 515 of the Charter of Cecil County.

31                   **NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County  
 32 approves the contract between Cecil County Government and RASTRAC Vehicle Tracking Service of Austin,  
 33 Texas, for RVTS Automatic Vehicle Location, AVL, services for sixty months, beginning on November 1,  
 34 2016 and ending on September 30, 2021 at a monthly cost of \$25.33 per vehicle for 116 County vehicles  
 35 for a 60 month term; and

36                   **AND, BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its  
 37 passage by the County Council of Cecil County, Maryland.
