Amendment - Master Water and Sewer Plan - Sewer Service Districts - Chesapeake City

1 **WHEREAS**, the Environment Article of the Annotated Code of Maryland requires the County to have
2 a Master Water & Sewer Plan and provides for the administration, enforcement, and amendment of Plan;
3 and

4 **WHEREAS**, an amendment has been proposed to the Master Water & Sewer Plan, to amend the
5 sewer service area map for Chesapeake City's sewer service districts as indicated as Exhibit A; and

6 **WHEREAS**, the previous map had omitted areas that should have been within the service area; and

7 **WHEREAS**, during a review by the Maryland Department of the Environment and Maryland
8 Department of Planning, there were some areas that were within the sewer service area that were omitted
9 in the map.

10 **WHEREAS**, the Department of Planning and Zoning has recommended approval of this amendment
11 to the Master Water & Sewer Plan, Sewer Service Districts, Chesapeake City; and

12 **WHEREAS**, a public hearing was held on these proposed changes before the Planning Commission on
13 Monday October 17, 2016; and

14 **WHEREAS**, the Planning Commission recommended approval of the proposed amendment.

15 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
16 the map amendment to the Master Water & Sewer Plan, Sewer Service Districts - Chesapeake City, as
17 indicated by Exhibit A, is hereby adopted.

18 **AND, BE IT FURTHER RESOLVED** that this map amendment shall be submitted to the Maryland
19 Department of the Environment for its approval pursuant to section 9-507 of the Environment Article of the
20 Annotated Code of Maryland.

21 **AND, BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by
22 the County Council of Cecil County, Maryland.
