Appointment – Board of Parks and Recreation - Jennifer Callaghan

1           **WHEREAS**, the Board of Parks and Recreation was created with powers and duties, pursuant to  
2 Chapter 16, Article II, Section 16-7 of the Code of Cecil County; and

3           **WHEREAS**, the Board of Parks and Recreation shall consist of eight members appointed by the  
4 County Executive and confirmed by the County Council who serve a three-year staggered term , and one  
5 member appointed by the Board of Education; and

6           **WHEREAS**, the Board of Parks and Recreation is authorized to determine all questions of general  
7 policy relating to parks and public recreation in Cecil County, to supervise the expenditure of funds  
8 appropriated to these purposes, and to keep the County informed as the availability of federal and state  
9 funds for these purposes according to Chapter 16, Article II, Section 16-9 of the Code of Cecil County; and

10           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
11 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;  
12 and

13           **WHEREAS**, the County Executive has appointed Jennifer Callaghan to serve on the Board of Parks  
14 and Recreation to fill the vacancy of George Raley, term to expire on January 3, 2020.

15           **NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County Council of Cecil County confirms the  
16 appointment by the County Executive of Jennifer Callaghan to serve on the Board of Parks and Recreation,  
17 term to expire on January 3, 2020.

18           **AND, BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by  
19 the County Council of Cecil County, Maryland.
