1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2016, the	
2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2017; and,	
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held	
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2017; and,	
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2016, the	
6	County Council adopted the budget for Fiscal Year 2017; and,	
7	WHEREAS, the County Executive is revising the Fiscal Year 2017 revenue estimate for Cecil County	
8	to increase use of Fund Balance by \$2,050 to allow the following appropriation within the General Fund:	
9	a) The addition of \$2,050 in expenditures to the Maryland School for the Blind's budget to	
10	accommodate the increase in tuition for the 2016 - 2017 school year.	
11	WHEREAS, such appropriation is necessary to provide \$2,050 of fund balance for the General Fund	
12	for expenditures within the Maryland School for the Blind budget; and,	
13	NOW THEREFORE, BE IT HEREBY RESOLVED that the Annual Budget and Appropriation Ordinance	
14	for Cecil County, Maryland for Fiscal Year 2017 is hereby amended for the supplemental appropriation	
15	and by amending the Current Budget to appropriate \$2,050 of additional expenditures in the Genera	
16	Fund.
