1 **WHEREAS**, the United States Congress enacted the Workforce Investment Act of 1998 to
2 consolidate, coordinate, and improvement employment, training, literacy, and vocational rehabilitation
3 programs in the United States; and

4 **WHEREAS**, the Workforce Innovation and Opportunity Act OF 2014 replaced the Workforce
5 Investment Act of 1993; and

6 **WHEREAS**, the purpose of the Workforce Investment Act is to provide work force investment
7 activities through the state and local investment systems that increase the employment, retention, and
8 earnings of participants and increase occupational skill attainment by participants that will improve the
9 quality of the work force, reduce welfare dependency, and enhance productivity and competitiveness in
10 the United States; and

11 **WHEREAS**, the Governor of each state shall designate local workforce investment areas within the
12 State; and

13 **WHEREAS**, the local workforce investment board will be established and certified by the Governor
14 of the State; and

15 **WHEREAS**, the Susquehanna Workforce Network is a private, non-profit corporation directed by a
16 board that oversees, coordinates, or plans workforce development programs and services for businesses
17 and individuals in Cecil and Harford Counties; and

18 **WHEREAS**, the Susquehanna Workforce Network seeks to identify needs and develop solutions
19 that maximize regional economic success and work potential; and

20 **WHEREAS**, membership in local workforce investment board shall include representatives of
21 business, education, labor organizations, community-based organizations, economic development
22 agencies, and the chief elected officials.

23 **WHEREAS**, the local workforce investment board shall develop a local plan in partnership with the
24 chief executive official to be submitted to the Governor; and

25 **WHEREAS**, the local plan shall include the workforce investment needs of businesses, jobseekers,
26 and workers in the local area, current and projected employment opportunities, job skills necessary to
27 obtain such employment opportunities, a description and assessment of the one-stop delivery system to
28 be established or designated, local levels of performance, type and availability of adult and dislocated

29 work employment and training, workforce activities coordination, youth activities and public comments;
30 and

31 **WHEREAS**, the Workforce Investment Act requires nominations for appointments and
32 reappointments to the Susquehanna Workforce Investment Board to be supported by a business
33 organization in the community; and

34 **WHEREAS**, members of the Cecil County Chamber of Commerce support the appointment of
35 Brian Heinbaugh, Jack Reitnauer, Dr. Mary Bolt, Carrie Bender and Carol Rose; and

36 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
37 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
38 and

39 **WHEREAS**, the County Executive has appointed Brian Heinbaugh and Jack Reitnauer to serve a 1
40 year term to expire June 30, 2017, Dr. Mary Way Bolt and Carrie Bender to serve a 2 year term to expire
41 June 30, 2018; and Carol Rose to serve a 3 year term to expire June 30, 2019.

42 **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
43 **MARYLAND**, approves the appointment to the Susquehanna Workforce Investment Board of Brian
44 Heinbaugh and Jack Reitnauer to a one-year term to expire on June 30, 2017; Dr. Mary Bolt and Carrie
45 Bender to a two-year appointment to expire on June 30, 2018; and Carol Rose to a three-year
46 appointment to expire on June 30, 2019; and

47 **AND, BE IT FURTHER RESOLVED** that all provisions of this Resolution shall take effect on the date
48 that the Resolution is adopted by the Council.
