Synopsis: An expedited Bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2017, in order to move forward the bond expenditure authority in the amount of \$600,000 requested for the Permitting System (61003) within the Information Technology General Capital Projects Funding, resulting in an increase to the current fiscal year 2017 and a reduction to FY 2018.

Budget Amendment - General Capital Project - Information Technology - Permitting System

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2016, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2017; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2017; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 7, 2016, the
6 County Council adopted the budget for Fiscal Year 2017; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2017 Information Technology General
8 Capital Projects Fund Budget to move bond revenue and expenditure authority from FY2018 to the
9 current 2017 fiscal year for the Permitting System project:

10 a.) Upon further review of the current system by the departments who use the
11 software,(Permits & Inspections, Planning and Zoning, Department of Public Works and
12 Finance) it was determined that upgrading the current system would serve the best interest
13 of the County and its citizens.

14 b.) To accomplish the upgrade, \$600,000 of the funds requested in FY2018 should be moved to
15 FY2017 in order to promptly start the upgrade of the software and allow for internet and
16 mobile enhanced technology for the departments and the citizens.

17 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**
18 **IN LEGISLATIVE SESSION** that the Annual Budget and Appropriation Ordinance for Cecil County,
19 Maryland for Fiscal Year 2017 is hereby amended to move forward the bond expenditure authority in
20 the amount of \$600,000 requested for the Permitting System (61003) within the Information
21 Technology General Capital Projects Fund resulting in a reduction to FY2018 and increase to the current
22 fiscal year 2017.
