30 WHEREAS, the Council shall determine its own governing structure including the appointment of a 31 chair; and 32 WHEREAS, the Council shall develop and submit a local plan to the Behavior Health Administration of the Maryland Department of Health and Mental Hygiene; and 33 WHEREAS, the local plan shall include the plans, strategies, and priorities of the county for 34 meeting identified needs of the general public and the criminal justice system for alcohol and drug abuse 35 evaluation, prevention, and treatment services; and 36 37 WHEREAS, the local plan shall also include a survey of all federal, State, local and private funds used in the county for alcohol and drug abuse evaluation, prevention and treatment; and 38 39 WHEREAS, the County Executive has appointed April Foster to the Cecil County Alcohol and Drug Abuse Council as a individual who is knowledgeable about treatment of substance abuse in the county. 40 NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, 41 42 MARYLAND that the appointment of April Foster to the Cecil County Drug and Alcohol Council for a three 43 year term is confirmed, term to expire on February 7, 2020; AND BE IT FURTHER RESOLVED that all provisions of this Resolution shall take effect on the date 44 45 that the Resolution is adopted by the Council.
