Title of Resolution: Supplemental Appropriation - Health Insurance Fund - Fund Balance

Synopsis: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2017 to increase the revenue estimate and budget expenditure authority within the Health Insurance Fund by a total of \$1,250,000 in order for the fund to have sufficient budgetary authority to pay incurred medical claims through year end, and to increase fund balance by \$1,250,000 to the General Fund in order to increase various departmental expenditures per Appendix A to provide a total of \$1,250,000 in additions to expenditures to the General Fund Budget.

1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2016, the County
2	Executive submitted a proposed budget to the County Council for Fiscal Year 2017; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2017; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 2, 2016, the
6	County Council adopted the budget for Fiscal Year 2017; and
7	WHEREAS, the Health Insurance Internal Service Fund currently has witnessed normal costs for most
8	employees; however, the plan is also experiencing a higher than normal number of high-dollar cases (the
9	Fund has seen more than 18 major cases so far this year versus a national norm of 5 for a plan the county's
10	size); the Fund therefore needs additional revenue from the County in order to meet current medical claim
11	payments through the end of the fiscal year and that these costs approximate \$850,000; and
12	WHEREAS, the County Executive has determined it is prudent for the Health Insurance Fund to re-
13	establish a fund balance to serve as a reserve for future major health events and has determined that a
14	minimum of \$400,000 should be added to the fund balance each year for five years to establish a
15	\$2,000,000 goal; and
16	WHEREAS, the County Executive is revising the Fiscal Year 2017 Health Insurance Internal Service
17	Fund Budget of Cecil County, Maryland to increase the revenue estimate and expenditure authority in the
18	total amount of \$1,250,000 to pay medical claims; and
19	WHEREAS, such appropriation is necessary to provide \$1,250,000 of fund balance from the General
20	fund for the increase in health care expenditures within the County Departments; and
21	WHEREAS, the County Executive is revising the Fiscal Year 2017 General Fund Expenditure Budget for
22	Cecil County, Maryland, to establish the following amounts within departmental budgets within the
23	General Fund as further detailed in Appendix A.
24	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
25	MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
26	Year 2017 is amended by increasing the revenue estimate and budget expenditure authority within the
27	Health Insurance Fund by a total of \$1,250,000 in order for the fund to have sufficient budgetary authority
28	to pay incurred medical claims through year end, and to increase fund balance by \$1,250,000 to the

General Fund in order to increase various departmental expenditures per Appendix A to provide a total of

\$1,250,000 in additions to expenditures to the General Fund Budget.
