1 **WHEREAS**, the Maryland Transit Administration is the designated recipient in Maryland for grants
2 under the Federal Transit Act; and

3 **WHEREAS**, the Administrator of the Maryland Transit Administration of the Maryland Department of
4 Transportation is authorized to make grants to counties and to local governments for a mass transportation
5 program of projects; and

6 **WHEREAS**, the contract for financial assistance will impose certain obligations upon the applicant,
7 including the provision by it of the local share of the project costs in the program; and

8 **WHEREAS**, it is required by the United States Department of Transportation in accordance with the
9 provisions of Title VI of the Civil Rights Act of 1964 that, in connection with the filing of an application for
10 assistance under the Federal Transit Act, the applicant give an assurance that it will comply with Title VI of
11 the Civil Rights Act of 1964 and the United States Department of Transportation requirements thereunder;

13 **WHEREAS**, it is the goal of the applicant that minority business enterprise be utilized to the fullest
14 extent possible in connection with this project, and that definite procedures shall be established and
15 administered to ensure that minority business shall have the maximum construction contracts, supplies,
16 equipment contracts, or consultant and other services.

17 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
18 **MARYLAND**, that the filing of the aforesaid application is hereby endorsed.

19 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that the
20 County Executive is hereby requested to endorse this resolution, thereby indicating approval thereof.

21 **AND BE IT FURTHER RESOLVED** that copies of this Resolution be sent to the Maryland Transit
22 Administration of the Maryland Department of Transportation.

23 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that all
24 provisions of this Resolution shall take effect on the date that the Resolution is adopted by the Council.
