Natural Gas Project

Vincent Fiorelli, Chesapeake Utilities, provided an update on his company's progress on the installation of natural gas along Route 40. He stated that the project included the installation of 8,000 feet of pipe, approximately two miles along Route 40 in the area the North East Creek. He stated that Chesapeake Utilities should complete the installation from Mechanics Valley Road to Belvidere Road by May or June 2017. Plans in the future include providing natural gas on the north and south sides of Route 272.

State Legislative Update

Council Manager Massey reviewed state legislation for the Council's consideration.

He stated that HB 621 Cecil County Board of Education Members - Salary has been withdrawn.

Bunky Luffman, Eastern Shore Governmental Affairs, notified the Council that Governor Hogan signed HB 684, which will result in Cecil County Public Schools receiving an additional \$191,000.
