COUNTY COUNCIL OF CECIL COUNTY WORK SESSION MINUTES May 2, 2017

Tourism Strategic Plan

Sandra Turner, Tourism Director, presented the Cecil County Tourism Strategic Plan 2017-2022. She reviewed the process of developing the strategic plan and statistics used to base the goals and objectives. Ms. Turner also provided a presentation of the impact of tourism on Cecil County, which included the tourism sales, labor income, tax receipts and employment. This strategic plan will be posted on the county's website.

Council President Bowlsbey recognized Ms. Turner for her efforts in developing an outstanding group of volunteers. Council questions and comments ensued.

Council Manager Report

Mr. Massey updated Council Members about upcoming meetings and events. He also reported that the Board of Health is scheduled on May 23, 2017 at 9am prior to the Council work session. He updated the Council on the strategic highway safety plan, medical cannabis and Worcester County CAFOs legislation. He encouraged support for Irish War Cry, trained by local Graham Motion, that is running in the Kentucky Derby.

Council Member Comments

Council President Bowlsbey commented on a notice from the Health Department that they would be putting building permit applicants on a waiting list until next year because of the drought and inability to test wells because of the very dry wet season. She asked Mr. Sennstrom about the impact of this delay. Mr. Sennstrom will look into this issue. In addition, Fred VonStaden will be invited to speak to the Council. Vice President Bowlsbey attended the Social Services Board meeting and commented on their functions. She also provided an accounting of state funds that are coming to Cecil County, which had been provided by Delegate Hornberger.

Councilwoman Gregory had no comments.

Vice President Schneckenburger attended the Tourism Partnership Breakfast and commented on the Tourism Awards. He also attended the Chamber of Commerce Legislative Relations Committee and commented on Carl Robert's stellar efforts in keeping on top of state legislation. He plans to attend the Economic Development Commission meeting, Port Deposit Gas House dedication and Asian Pacific American Heritage Month celebration.

Councilman Patchell and Councilman Meffley had no comments.
