1 **WHEREAS**, Section 411 of the Charter of Cecil County provides that the County Attorney shall be the
2 chief legal officer of the County, and be a legal advisor to the Cecil County Council; and

3 **WHEREAS**, the County Executive appointed Jason Allison as County Attorney, which was confirmed by
4 the County Council on January 15, 2015; and

5 **WHEREAS**, Mr. Allison has provided sound legal opinions and advice to the County Council; and

6 **WHEREAS**, the County Attorney represents the County Executive, all departments and other
7 instrumentalities of the County Government in Cecil County; and

8 **WHEREAS**, Section 213 of the Charter of Cecil County provides that the County Council may by
9 resolution, at its discretion and subject to the provisions of its budget or supplementary appropriations,
0 employ legal advisors as it deems necessary to perform its functions; and

1 **WHEREAS**, the County Council solicited expressions of interest for an attorney to provide legal services
2 to the County Council; and

3 **WHEREAS**, the Council wishes to appoint Victor R. Jackson, LLC as Council Attorney.

4 **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**
5 **MARYLAND**, designates Victor R. Jackson, LLC as Council Attorney as of July 1, 2017.

6 **BE IT FURTHER RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that all
7 provisions of this Resolution shall take effect on the date the Resolution is adopted by the Council.

8 **AND BE IT FURTHER RESOLVED THAT THE COUNTY COUNCIL** authorizes the Council President to sign
9 the agreement with Victor R. Jackson, LLC on behalf of the County Council.
