# COUNTY COUNCIL OF CECIL COUNTY **WORK SESSION MINUTES** May 23, 2017

## **Approval of Minutes**

On a motion made by Councilwoman Gregory, seconded by Councilman Meffley, the Council moved to approve the minutes of the Council work session of May 16, 2017, as presented. Motion was approved by a vote of 4 to 0. Vice President Schneckenburger was absent.

### **Budget Public Hearing**

Council President Bowlsbey led discussion regarding the public hearing on the budget bills to be held tonight at 7:00 p.m. at Elkton High School. The Council agreed by consensus to limit each speaker to three minutes. Council Members were reminded that they should not respond to any questions by the audience during the public hearing. Council President Bowlsbey will give opening and closing remarks. Al Wein, Director of Administration, will summarize the proposed budget.

Council President Bowlsbey led discussion regarding the budget deliberation sessions scheduled on May 30, 2017 and June 1, 2017. The Council agreed by consensus to schedule the preliminary sessions at 9 a.m. on May 30, 2017. Council President Bowlsbey stated that Mayor Joe Zang requested that the Council send a letter of support for a grant application from the Town of Cecilton for the Cecilton Elderly Housing to the Maryland Department of Housing and Community Development.

Councilman Patchell made a motion to send a letter of support on behalf of the Town of Cecilton, which was seconded by Councilman Meffley. By a voice vote, the Council agreed to send the letter of support by a vote of 4 to 0. Vice President Schneckenburger was absent.
