WHEREAS, a local jurisdiction may establish by local law a planning commission with the powers and
duties, pursuant to the Land Use Article of the Annotated Code of Maryland, Section 2-101. Authority to
establish, Subtitle 1. Organization and General Authority, Title 2. Planning Commission, Division I. Single-
Jurisdiction Planning and Zoning; and
WHEREAS, the Cecil County Board of Appeals shall consist of five regular members and one alternate
member, who must be residents of Cecil County; pursuant to the Land Use Article in the Annotated Code of
Maryland, Section 9-704 Board of Appeals, Subtitle 7. Cecil County, Title 9. Single-Jurisdiction Planning and
Zoning; and
WHEREAS, the Cecil County Board of Appeals shall be appointed by the County Executive and
approved by the County Council, pursuant to Section 298. Board of Appeals Established, Part II. Board of
Appeals, Article XVI. Administrative Mechanisms, of the Cecil County Zoning Ordinance; and
WHEREAS, the power and duties of the Board of Appeals are to hear and decide appeals when it is
alleged that there is an error in any order, requirement, decision, or determination made by the Zoning
Administrator or any other administrative official in the enforcement of the zoning ordinance; and to hear and
decide special exceptions as provided in the zoning ordinance; and to authorize upon application a variance
from the provisions of the zoning ordinance; and
WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County Executive
shall appoint all members of boards and commissions, subject to confirmation by the Council;
WHEREAS, The County Executive has reappointed Brad Carrillo and Michael Linkous to the Board of
Appeals for a three year term to expire August 15, 2020.
