1 **WHEREAS**, pursuant to Maryland Annotated Code, Agriculture Article, Subtitle 5. Maryland
2 Agricultural Land Preservation Foundation, Section 2-504.1, an Agricultural Preservation Advisory Board
3 shall be appointed by the elected body by each county, which has productive agricultural land; and

4 **WHEREAS**, the Agricultural Preservation Advisory Board shall consist of five members, at least
5 three of whom shall be owner-operators of commercial farms who earn fifty percent or more of their
6 income from farming; and

7 **WHEREAS**, each member of the Agricultural Preservation Advisory Board shall be appointed for a
8 term of office of five years, and no member shall serve for more than two consecutive full terms; and

9 **WHEREAS**, the duties of the Agricultural Preservation Advisory Board shall be to advise the county
10 governing body with respect to the establishment of agricultural districts and the approval of purchases of
11 easements by the Foundation within the county, to review the status of agricultural districts and land
12 under easement, to advise the Foundation concerning county priorities for agricultural preservation, to
13 approve applications by the county for certification, to promote preservation of agriculture within the
14 county; and to meet at least annually with forest conservation district boards in order to work
15 cooperatively to encourage the promotion and retention of farmland and woodland in their jurisdictions;
16 and

17 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
18 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
19 and

20 **WHEREAS**, the County Executive has reappointed Shelley Hastings to serve on the Agricultural
21 Preservation Advisory board term to expire August 15, 2022.

22 **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**
23 **MARYLAND** confirms the reappointment of Shelley Hastings to the Agricultural Preservation Advisory
24 Board, term to expire August 15, 2022.

25 **AND BE IT FURTHER RESOLVED** that all provisions of this Resolution shall take effect on the date
26 that the Resolution is adopted by the Council.
