# **COUNTY COUNCIL OF CECIL COUNTY WORK SESSION MINUTES** July 11, 2017

## **OPEN SESSION – Elk Room**

9:00 A.M. -Council President Bowlsbey called the meeting to order at 9:00 a.m. and determined a quorum.

### Approval of Minutes

On a motion made by Councilman Patchell, seconded by Vice President Schneckenburger, the Council moved to approve the minutes of the Council work session of June 20, 2017, as presented. Motion was approved by a vote of 3 to 0. Councilman Meffley and Councilwoman Gregory were absent.

Councilman Meffley and Councilwoman Gregory arrived at 9:07 a.m.

# Solar Power Generating Facility - SunEast Development

Mr. Thomey introduced Joe Kelly, SunEast Business Development Manager and Chesapeake Solar Project Manager; Marcia Haas, SunEast Business Development Manager and Chesapeake Solar Community Relations Manger and Dan Speakman, McCrone Engineering.

Mr. Thomey stated that SunEast Development is to construct a solar power generating facility on Route 213, north of Chesapeake City, which is proposed to utilize a 9megawatt single axis tracking solar panels. There will be 40,000 solar panels located on 55 acres of this 100 acre site. This \$17M project will generate power that will be offered to government and nonprofit organizations through Delmarva Power. Mr. Thomey stated that this project is going through the Public Service Commission for approval. Area residents will be receiving information on the proposal and invitations to attend a public meeting.

Mr. Kelly stated that where the proposed facility will be located on the site will be to minimize the environmental impact to the surrounding area. The facility will be enclosed by a eight foot high fence and tree plantings to minimize the site view of the solar panels to the public.

Ms. Haas stated that native plants that pollinate will be planted to encourage honey bees and butterflies. Plans also will be made for educational opportunities regarding the benefits of solar energy and pollination.

Mr. Speakman commented on the engineering aspects of the project.

Council questions and comments ensued.

## **Taxicab Regulations**

Alan Johnson from Key Lime Taxi gave a presentation about his concerns of county taxicab companies and the need for local regulations. He described his taxicab company and policies for his cabs, which included using GPS for monitoring, meters to measure miles and amounts of fare, and his dispatch operation. He stated his concerns about other taxicab companies in the county that do not post their rates or display a meter visible to the public. He also stated his concern that vehicles used for cabs may not operating safely and could pose a hazard to riders.

Council questions and comments ensued. The Council discussed the issue of background checks for taxi drivers, vehicle safety inspections, and other safety concerns.

The Council will be discussing this issue in considering possible regulations.

# **Poultry House CAFOs Ad Hoc Committee**

Council President Bowlsbey led discussion of the proposal to establish an ad hoc committee to develop recommendations for poultry house CAFOs legislation. The Council discussed possible members of the committee.

The Council agreed to discuss in today's closed session under appointments related to personnel matter.

# Winery and Conference Center Zoning

Councilwoman Gregory led discussion of the inconsistency of the zoning regulations regarding uses associated with wineries and conference centers. She explained that the current zoning code has different standards for these zoning codes, but the uses for weddings, concerts, and parties could be held at either venue.

Mr. Sennstrom explained the existing zoning requirements for wineries and conference centers. He also spoke about the property of the former Elk Manor Winery that had been zoned as a winery but had been holding weddings and other public events.

The Council asked the administration to look at these inconsistencies of the zoning code and provide definitions or guidelines that could treat these uses consistently.

# **Review of Legislative Agenda**

Council President Bowlsbey led a review of tonight's legislative agenda.

Mr. O'Connor provided brief remarks about the rezoning case, #2017-04 Penntex Ventures LLC. There were no Council questions or comments.
