Local Boards, Section 3-503, defines the duties and 2 3 functions of a local Social Services Board as an advisory board to the local director for the local application 4 and implementation of State policies or procedures, which includes evaluating and making recommendations to improve current services and develop new services as needed in the county; and 5 6 serving as the liaison with the local government authority and residents to communicate the objectives, 7 policies and programs of local social services and public assistance administration; and 8 WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County 9 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; 10 and WHEREAS, the County Executive has reappointed Raymond W.
