1 **WHEREAS**, a local jurisdiction may establish by local law a planning commission with the powers and
2 duties set forth in this division, pursuant to the Land Use Article of the Annotated Code of Maryland, Section
3 2-101; and

4 **WHEREAS**, the Cecil County Planning Commission was established and consists of six members plus an
5 alternate who shall serve in the absence of a regular member; and a member of the County Council who
6 serves as an ex-officio, non-voting member; pursuant to the Cecil County Zoning Ordinance, Section 295;
7 Article XVI.; and

8 **WHEREAS**, each Planning Commission member serve three year terms and must be a resident of Cecil
9 County; and

0 **WHEREAS**, the duties of the Planning Commission are to review, evaluate, and approve or disapprove
1 plans for subdivisions in accordance with the Zoning Ordinance and Subdivision Regulations; and to review
2 and make recommendations to the Cecil County Council regarding proposed changes or amendments to the
3 Comprehensive Plan, Chesapeake Bay Critical Area Program, Zoning Ordinance, Subdivision regulations, Road
4 Code, Master Water and Sewer Plan, acquisition and development of lands for open space or recreation
5 purposes, historic sites or districts, land use or development arising from state or federal programs or policies,
6 Forest Conservation Regulations; and to review the Capital Improvement Program annually; and to make
7 recommendations to the Board of Appeals regarding applications for special exceptions; and

8 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County Executive
9 shall appoint all members of boards and commissions, subject to confirmation by the Council; and

0 **WHEREAS**, The County Executive has approved the reappointment of A. Chad Johnston and the
1 appointment of Peter Kirsh, replacing Ken Wiggins to the Planning Commission term to expire August 15,
2 2020.

3 **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**
4 **MARYLAND** confirms the reappointment of A. Chad Johnston and the appointment of Peter Kirsh, replacing
5 Ken Wiggins to the Planning Commission; term to expire August 15, 2020.

6 **AND, BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by the
7 County Council of Cecil County, Maryland.
