WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2017, the 1 2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2018; and 3 WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held 4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2018; and 5 WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 15, 2017, the Budget for Cecil County was adopted for Fiscal Year 2018; and 6 7 WHEREAS, the County Executive requests County Council to revise General Fund expenditure 8 appropriations to provide \$353,320 of expenditure authority from the Development Services Division of the Department of Public Works to the new Development Plans Review Division of the Department of 9 10 Land Use and Development Services to accommodate the merger of plans review with the planning 11 function. The merger was announced after the FY2018 budget was introduced to County Council and the FY2018 budget did not take into account the budgetary changes of staff and operations that needed to be 12 13 transferred. NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, 14 MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal 15 Year 2018 is amended for the supplemental appropriation and by amending the Current Budget to 16 appropriate \$353,320 to Land Use & Development Services Department, Development Plans Review 17 Division and reduce the appropriation by \$353,320 in the Department of Public Works Development 18 Services Division. 19 20 AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that 21 this Resolution shall take effect on the date of its passage by the County Council of Cecil County,
