1	WHEREAS, Pursuant to Section 203 of the County Charter provides that the County Council may
2	appoint special ad hoc committees solely for the purpose of inquiry and fact finding; and
3	WHEREAS, Pursuant to Section 412(c) of the County Charter provides that the membership of
4	boards and commissions that are established exclusively to advise the Council shall be appointed and
5	removed by the Council, at the Council's discretion; and
6	WHEREAS, Agriculture has dominated the Cecil County landscape and economy for centuries, and
7	county farmers produce their crops and livestock for local, regional, national and international
8	marketplaces; and
9	WHEREAS, Cecil County's mid-Atlantic location on the I-95 corridor is sought after by families and
10	businesses for homes and commercial development; and
11	WHEREAS, Cecil County must balance the interests of agriculture with that of development so that
12	the economy can prosper from its location and geographical beauty; and
13	WHEREAS, Cecil County has a "Right to Farm" ordinance that encourages that operation of
14	agriculture without interference from other land uses; and
15	WHEREAS, farmers and residents of the community have expressed support for environmental
16	regulations of Confined Animal Feeding Operations, CAFOs, and in regulation of poultry feeding
17	operations; and
18	WHEREAS, CAFOs are highly regulated and subject to oversight of the Maryland Department of
19	Agriculture and the Department of the Environment; and
20	WHEREAS, the County Executive has issued Executive Order 01-2017 in February 2017, which
21	orders the Cecil Soil Conservation District Agents to collaborate with the Director of Land Use and
22	Development Services in implementing best management practices; and
23	WHEREAS, the County Council of Cecil County has reviewed recommendations from agricultural
24	and environmental experts as to the potential hazards of operating CAFOs, which has resulted in several
25	eastern shore counties updating their CAFOs regulations to reflect the concerns of the community; and

Creation and Appointment – Poultry House CAFOs Committee

WHEREAS, the County Council of Cecil County has reviewed many documents and testimonies about the operation of poultry house CAFOs that present diverse facts and opinions about the safety and potential hazards: and WHEREAS, the County Council wishes to be a catalyst in this effort to determine what, if any, regulations of poultry house CAFOs should be implemented in Cecil County. NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that a Poultry House CAFOs Committee shall be created as an ad hoc committee to advise the Council; and BE IT FURTHER RESOLVED that the Poultry House CAFOs Committee shall be charged with developing recommendations as to any regulations that should be implemented regarding the operations of poultry house CAFOs in Cecil County; and BE IT FURTHER RESOLVED that the committee will be composed of the following members as appointed by the County Council; two members from the Cecil County Farm Bureau, two members from Calvert Neighborhood Alliance, one member from the Cecil County Health Department, one member from the Cecil County Public Schools, one member from the Delmarva Poultry Industry, Inc., and three members from the general community; and BE IT FURTHER RESOLVED that all Council Members will be ex-officio members of the Poultry House CAFOs committee; and BE IT FURTHER RESOLVED that the Poultry House CAFOs Committee will develop recommendations that will be presented to the County Council by October 1, 2017; and BE IT FURTHER RESOLVED that the Poultry House CAFOs Committee will be dissolved, without further action of the County Council of Cecil County, on October 1, 2017.
