WHEREAS, pursuant to Section 157-1 (B) of the Code of Cecil County, Maryland, the 2015 International 1 Residential Code was adopted as an addition to the Building Code of Cecil County, Maryland, and 2 WHEREAS, pursuant to Section R112 of the 2015 International Residential Code, a Building Board of 3 Appeals is established to hear and decide appeals of orders, decisions, or determinations made by the building 4 officials relative to the application and interpretation of the Residential Code; and 5 WHEREAS, members of the Building Board of Appeals shall be qualified by experience and training to 6 pass judgment on matters pertaining to building construction and are not employees of Cecil County; and 7 WHEREAS, terms of the first appointed members of the Building Board of Appeals shall be in graduated 8 term lengths of one year, two years, three years, four years and five years; and 9 WHEREAS, after the first appointed board, each new member shall serve for five years or until a 0 successor has been appointed; and 1 WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County Executive 2 shall appoint all members of boards and commissions, subject to confirmation by the Council; 3 WHEREAS, The County Executive approves the reappointment to the Building Board of Appeals of 4 Leroy H. Scott III for a one year term to expire on August 15, 2018; and 5 NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, 6 MARYLAND, confirms the reappointment to the Building Board of Appeals of Leroy Scott III for a one year 7 term to expire on August 15, 2018. 8 AND BE IT FURTHER RESOLVED by the County Council of Cecil County, that all provisions of this 9 Resolution shall take effect on the date that the Resolution is adopted by the Council. 0
