1 **WHEREAS**, pursuant to Section 157-1 (B) of the Code of Cecil County, Maryland, the 2015 International
2 Residential Code was adopted as an addition to the Building Code of Cecil County, Maryland, and

3 **WHEREAS**, pursuant to Section R112 of the 2015 International Residential Code, a Building Board of
4 Appeals is established to hear and decide appeals of orders, decisions, or determinations made by the building
5 officials relative to the application and interpretation of the Residential Code; and

6 **WHEREAS**, members of the Building Board of Appeals shall be qualified by experience and training to
7 pass judgment on matters pertaining to building construction and are not employees of Cecil County; and

8 **WHEREAS**, terms of the first appointed members of the Building Board of Appeals shall be in graduated
9 term lengths of one year, two years, three years, four years and five years; and

0 **WHEREAS**, after the first appointed board, each new member shall serve for five years or until a
1 successor has been appointed; and

2 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County Executive
3 shall appoint all members of boards and commissions, subject to confirmation by the Council;

4 **WHEREAS**, The County Executive approves the reappointment to the Building Board of Appeals of
5 Leroy H. Scott III for a one year term to expire on August 15, 2018; and

6 **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
7 **MARYLAND**, confirms the reappointment to the Building Board of Appeals of Leroy Scott III for a one year
8 term to expire on August 15, 2018.

9 **AND BE IT FURTHER RESOLVED** by the County Council of Cecil County, that all provisions of this
0 Resolution shall take effect on the date that the Resolution is adopted by the Council.
