1           **WHEREAS**, Pursuant to Article I, Section 270-5 of the Code of Cecil County, Maryland, the County  
2 Executive, in accordance with the Charter, shall annually appoint a County Plumbing Board, which shall consist  
3 of three members made up of a representative of the Master Plumbers Association of the County, the Health  
4 Officer, an architect, engineer, or building and/or any combination thereof; and

5           **WHEREAS**, Pursuant to Article I, Section 270-5 of the Code of Cecil County, the County Plumbing Board  
6 shall meet at the request of the Chairman or when it is deemed necessary to resolve disputes concerning  
7 plumbing installation; and

8           **WHEREAS**, The County Plumbing Board shall hear and decide all questions in dispute between property  
9 owners, or their agents, and the Plumbing Inspector; and

0           **WHEREAS**, The County Plumbing Board shall act as an advisor to the County with respect to the  
1 administration and enforcement of the provisions of the Code of Cecil County, Chapter 270 Plumbing; and

2           **WHEREAS**, Pursuant to Section 412(b) of the Charter of Cecil County, the Executive shall appoint all  
3 members of boards and commissions and that such membership shall be subject to confirmation by the  
4 Council; and

5           **WHEREAS**, The County Executive approves the reappointment of Ronald Dixon, Thomas Vaughn, Sr.,  
6 and Melvin Reburn to the Cecil County Plumbing Board, term to expire on August 15, 2018.

7           **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
8 **MARYLAND**, confirms the reappointment of Ronald Dixon, Thomas Vaughn, Sr., and Melvin Reburn to the  
9 Cecil County Plumbing Board, term to expire on August 15, 2018.

0           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that all  
1 provisions of this Resolution shall take effect on the date that the Resolution is adopted by the Council.
