6	2018; and
7	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 15, 2017,
8	the Budget for Cecil County was adopted for Fiscal Year 2018; and
9	WHEREAS, the County Executive is revising the Fiscal Year 2018 Casino Local Impact Fund
10	revenue estimate for Cecil County to carry forward from fund balance within the Casino Local
11	Impact Fund the following amounts:
12	a) To carry forward \$4,000 in VLT grant funds awarded to the Boy's & Girls' Club and;
13	b) To carry forward \$1,356.83 in VLT grant funds awarded to Maryland State Police North
14	East, and;
15	c) To carry forward \$5,500 in VLT grant funds awarded to North Bay, and;
16	d) To carry forward \$4,474.51 in VLT grants funds awarded to Voices of Hope, and;
17	WHEREAS, such appropriation is necessary to provide \$15,331.34 of grant funding for the
18	Casino Local Impact Fund for grant related expenses within the VLT Local Community Grant Funds
19	due to the full award being unspent during the original grant period.
