WHEREAS, pursuant to Section 23-401 of the Education Article of the Annotated Code of 1 Maryland, the county governing body may establish a county public library system free from political 2 influence; and 3 WHEREAS, each county public library system shall be governed by a board of trustees; and 4 WHEREAS, pursuant to Section 23-403 of the Education Article of the Annotated Code of 5 Maryland, each board of library trustees consists of seven members appointed by the county governing 6 7 body from nominees submitted by the board of library trustees; and WHEREAS, pursuant to Section 23-405 of the Education Article of the Annotated Code of 8 Maryland, each board of library trustees has the powers and duties to establish and operate the library, 9 determine library policies, adopt rules, regulations and bylaws for the use of the library, approve the 10 library budget and spending of public funds, and approve of the annual audit and annual report; and 11 WHEREAS, Section 412 (b) of Article 4 of the Charter of Cecil County provides that the County 12 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; 13 14 and WHEREAS, the County Executive has appointed Phyllis Kilby to the Cecil County Board of Library 15 Trustees, to complete the term of Stephen Naughton who retired from the board; and 16 NOW, THEREFORE, BE IT HEREBY RESOLVED that the County Council of Cecil County confirms the 17 appointment, by the County Executive, of Stephen Naughton to the Cecil County Board of Library 18 Trustees, term to expire on January 30, 2018. 19 AND, BE IT FURTHER RESOLVED that this Resolution shall take effect on the date of its passage by 20 the County Council of Cecil County, Maryland. 21
