COUNTY COUNCIL OF CECIL COUNTY LEGISLATIVE SESSION MINUTES LSD 2017-17 September 5, 2017

The County Council of Cecil County met in legislative session at the County Administration Building, 200 Chesapeake Blvd., Elk Room, Elkton, MD. The following members of the Council were present:

CALL TO ORDER

The meeting of the County Council of Cecil County of September 5, 2017 was called to order by Council President Bowlsbey at 7:00 p.m. and opened with the Pledge of Allegiance.

MOMENT OF SILENCE

Council President Bowlsbey led the Council in a moment of silence.

APPROVAL OF AGENDA

On motion made by Vice President Schneckenburger, seconded by Councilman Meffley, moved to approve the legislative agenda of September 5, 2017. Motion carried unanimously.

PUBLIC HEARING

Council Manager Massey stated for the record:

Bill No. 2017-16 General Obligation Bond Authorization

Synopsis: An Act authorizing and empowering Cecil County, Maryland, from time to time, to borrow not more than Forty Two Million Four Hundred Thousand Dollars (\$42,400,000) for the purpose of financing the costs of certain public facilities in Cecil County described herein, and to effect such borrowing by the issuance and sale of its general obligation bonds in one or more series; empowering the County Executive to execute and deliver one or more executive orders prior to issuing the bonds in order to fix, prescribe and determine the details of the bonds and the issuance and sale thereof; empowering and directing the County to levy ad valorem taxes in rate and amount sufficient to provide funds for the payment of the maturing principal of and interest on the bonds; exempting the bonds from the provisions of Sections 19-205 and 19-206 of the Local Government Article of the Annotated Code of Maryland, or successor provision; authorizing the County to issue and sell bond anticipation notes in one or more series pursuant to the authority of Sections 19-211 through 19-221 of the Local Government Article of the Annotated Code of Maryland, or successor provision, prior to and in anticipation of the sale of the bonds; providing that the County may issue and sell all or any portion of the bonds as bonds, the interest on which is not excludable

from gross income for federal income tax purposes; and relating generally to the issuance and sale of such bonds.

The Bill was introduced on August 1, 2017, advertised on August 16, 2017 and August 23, 2017, and scheduled for public hearing on September 5, 2017.

Al Wein, Director of Administration, provided comments about this legislation. There were no Council questions or comments.

Council President Bowlsbey opened the public hearing for comments. There were no public comments.

Council President Bowlsbey concluded the public hearing on Bill No. 2017-16 and announced that final consideration of this Bill will be held on September 19, 2017.

Council President Bowlsbey commented on her thoughts and prayers for Houston and concern for the next hurricane coming to the East Coast.

A Bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2018, to move forward the project, including bond expenditure authority in the amount of \$184,000 requested for the boiler project at Rising Sun Elementary School within the Board of Education General Capital Projects Fund resulting in a reduction to FY2019 and an increase to the current 2018 fiscal year. This change will also be reflected in the Capital Projects Program.

The Bill was introduced on July 18, 2017 and public hearing held and concluded on August 15, 2017.

A Bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2018 to transfer existing bond appropriation authority within the Board of Education Capital Projects Budget in the amount of \$81,574.42 from completed School Capital Projects (Perryville Elementary Renovations \$44,169.25, Cecilton Elementary Exterior Envelope \$4,399.47, Perryville High School Cooling Tower \$3,044, Boiler Replacement Projects at Kenmore, Thomson Estates Elementary, Cherry Hill Middle, and Bohemia Manor \$29,961.70) to the North East High Schools' Girls' Locker Room Renovation Project.
