1	WHEREAS, the Department of Commerce of the State of Maryland (the "Department") has agreed
2	to conditionally loan to Project Melo (the "Borrower") up to \$1,200,000 from the Maryland Economic
3	Development Assistance and Authority Fund ("MEDAAF") (the "MEDAAF Loan"); and
4	WHEREAS, the MEDAAF Loan proceeds will be loaned to the Borrower to establish a new 1M plus
5	square foot distribution center at the Principio Business Park in North East, Cecil County, Maryland (the
6	"Project"); and
7	WHEREAS, the Project plans call for anticipated project costs at the project site of approximately
8	\$16M for land acquisition, \$65M to construct and improve the site, and \$3M for equipment, and the
9	Borrower further expects to hire 225 permanent full-time employees at the Project Site by December 31,
10	2021, and an additional 225 permanent full-time employees at the Project Site by December 31, 2023, for
11	a total of 450 permanent full-time employees at Principio Business Park location (the "Project Site"); and
12	WHEREAS, pursuant to the Maryland Economic Development Assistance Fund, Sections 5-301
13	through 5-349 of the Economic Development Article of the Annotated Code of Maryland (the "MEDAAF
14	Statute"), the County Council of Cecil County, Maryland (the "County") must endorse the making of the
15	MEDAAF Loan for the Project; and
16	WHEREAS, as required by the MEDAAF Statute, the County will contribute \$170,000 toward the
17	Project in the form of a conditional loan to the Borrower disbursed over a period not to exceed 10 years
18	under certain terms and conditions to be reduced to writing by and between the County and the
19	Borrower (the "County Loan"); and
20	WHEREAS, the County has determined and expressly finds that it is in the best interest of the
21	citizens of Cecil County that it endorse the making of the MEDAAF Loan for the Project.
22	NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,
23	that the County hereby fully endorses the making of the MEDAAF Loan for the Project;
24	AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that
25	the County hereby approves the County Loan of \$170,000 for the Project, upon terms and conditions to
26	be negotiated by the County Executive;
27	AND, BE IT FURTHER RESOLVED that this Resolution shall be effective upon its adoption in
28	accordance with applicable law.
