The County Council of Cecil County met in legislative session at the County Administration Building, 200 Chesapeake Blvd., Elk Room, Elkton, MD. The following members of the Council were present:

CALL TO ORDER

The meeting of the County Council of Cecil County of September 19, 2017 was called to order by Council President Bowlsbey at 7:00 p.m. and opened with the Pledge of Allegiance.

MOMENT OF SILENCE

Council President Bowlsbey led the Council in a moment of silence.

APPROVAL OF AGENDA

On motion made by Councilwoman Gregory, seconded by Vice President Schneckenburger, moved to approve the legislative agenda of September 19, 2017. Motion carried unanimously.

PRESIDENT AND COUNCIL COMMENTS

Councilman Patchell had no comments.

Councilwoman Gregory thanked the audience for attending and invited the public to participate in Cecil Cares Day of Service. She commented on the mandated sewer hookup and her support for property owner rights.

Vice President Schneckenburger thanked the audience for attending and commented on public oppositions to the proposed mandatory sewer hookup and Resolution No. 44-2017 Council final reading of bills. He stated that the County Executive sets the policy for water and sewer, but alternatives are being considered.

Councilman Meffley commented on the mandatory sewer hookup and possible alternatives. He commented on the increase in property value when sewer service is provided and that he hoped a compromise could be found.

Council President Bowlsbey stated that she wanted to comment on misinformation that had been expressed. She stated that hookup fees have been reduced from \$12,000 to \$6,000 and the county has offered to finance over time. She stated that extending sewer lines along Route 40 in the development envelope between Route 7 and I-95 is needed for industrial development that will provide jobs. She stated that Maryland has no school head taxes and that school funding comes from the county and state budgets. She stated that farmers' use of fertilizer is regulated by their nutrient management plan, which is regulated by the State. She also stated that fuel tax on gasoline goes directly to the State, not the County She stated that Cecil County's tier maps were not approved by the State.

A Resolution to authorize and empower Cecil County, Maryland to borrow, from time to time, not more than Twenty One Million Seven Hundred Seventy Four Thousand Dollars (\$21,774,000) and to effect such borrowing by the issuance and sale of its general obligation bonds in one or more series, authorized by Section 19-207 of the Local Government Article of the Annotated Code of Maryland, such bonds to be sold

and issued for the purpose of refunding certain outstanding general obligation bonds of the County in order to realize savings to the County in the total cost of debt service; to empower the County Executive to execute and deliver one or more executive orders prior to issuing the bonds in order to fix, prescribe determine certain matters relating to such bonds and the sale thereof, as hereinafter described; to profor the levy and collection of taxes in rate and amount sufficient, together with funds from other sources, to pay the principal of and interest on such bonds as they mature; and to provide for and determine certain matters in connection with the sale, issuance and delivery of such bonds.

The Resolution was introduced and posted on August 1, 2017.

CALL FOR FINAL READING OF BILLS

Council Manager Massey stated for the record:

Bill No. 2017-16 General Obligation Bond Authorization

An Act authorizing and empowering Cecil County, Maryland, from time to time, to borrow not more than Forty Two Million Four Hundred Thousand Dollars (\$42,400,000) for the purpose of financing the costs of certain public facilities in Cecil County described herein, and to effect such borrowing by the issuance and sale of its general obligation bonds in one or more series; empowering the County Executive to execute and deliver one or more executive orders prior to issuing the bonds in order to fix, prescribe and determine the details of the bonds and the issuance and sale thereof; empowering and directing the County to levy ad valorem taxes in rate and amount sufficient to provide funds for the payment of the maturing principal of and interest on the bonds; exempting the bonds from the provisions of Sections 19-205 and 19-206 of the Local Government Article of the Annotated Code of Maryland, or successor provision; authorizing the County to issue and sell bond anticipation notes in one or more series pursuant to the authority of Sections 19-211 through 19-221 of the Local Government Article of the Annotated Code of Maryland, or successor provision, prior to and in anticipation of the sale of the bonds; providing that County may issue and sell all or any portion of the bonds as bonds, the interest on which is not excludable from gross income for federal income tax purposes; and relating generally to the issuance and sale of such bonds.

The Bill was introduced on August 1, 2017 and public hearing held and concluded on September 5, 2017.

Council questions and comments ensued.

On motion made by Vice President Schneckenburger, seconded by Councilman Meffley, the Council moved to approve Bill No. 2017-16.

Roll Call Vote: Meffley-Y, Patchell-Y, Gregory-N, Schneckenburger-Y, Bowlsbey-Y. Motion was approved by a vote of 4 to 1. Councilwoman Gregory was opposed.

ADJOURNMENT

On motion made by Councilwoman Gregory, seconded by Councilman Meffley, Council President Bowlsh adjourned the meeting at 8:09 p.m.
