Approval - Transfer of Real Property - Town of Rising Sun - Rails to Trails

WHEREAS, Section 12-405(b)(1) of the Local Government Article of the Annotated Code of Maryland provides that the governing body of Cecil County may sell by public or private sale or lease surplus county real property, and executive and acknowledge any instrument necessary to transfer the property; and

WHEREAS, pursuant to Section 12-405(b)(2) of the Local Government Article of the Annotated Code of Maryland provides that the governing body may contract to transfer an interest in county real property after a public hearing has been held and advertised for two weeks in a newspaper of general circulation in the county prior to the public hearing; and

WHEREAS, the County Executive proposes that Cecil County, Maryland, enter into an Agreement of Sale with the Town of Rising Sun, in substantially the form as attached as Appendix 1, to enable the County to transfer real property more fully described in the metes and bounds description attached hereto as Appendix 2 and as depicted on that Soil Erosion and Sediment Control Plan dated May 8, 2006, a copy of which is attached hereto as Appendix 3, in the Sixth Election District, Cecil County, Maryland; and

WHEREAS, the total consideration of purchase for the property will be One Dollar (\$1.00) and the restriction that the subject real property be used by the Town of Rising Sun as part of its Rails to Trails program; and

WHEREAS, the Town of Rising Sun has expressed an interest in acquiring the subject property for use as part of its Rails to Trails Program; and

WHEREAS, in accordance with 16 U.S.C. §1247(d)(Interim use of railroad rights-of-way), the Secretary of Transportation, the Chairman of the Surface Transportation Board, and the Secretary of the Interior, in administering the Railroad Revitalization and Regulatory Reform Act of 1976 [45 U.S.C. 801 et seq.], encourages State and local agencies and private interests to establish appropriate trails using the provisions of such programs; consistent with the purposes of that Act, and in furtherance of the national policy to preserve established railroad rights-of-way for future reactivation of rail service, to protect rail transportation corridors, and to encourage energy efficient transportation use, in the case of interim use of any established railroad rights-of-way pursuant to donation, transfer, lease, sale, or otherwise in a manner consistent with the aforementioned chapter, where, as here, such interim use is subject to restoration or reconstruction for railroad purposes, such interim use shall not be treated, for purposes of any law

Approval - Transfer of Real Property - Town of Rising Sun - Rails to Trails or rule of law, as an abandonment of the use of such rights-of-way for railroad purposes, and neither this Resolution or the underlying conveyance shall be deemed an abandonment or discontinuance inconsistent or disruptive of such future use as a railway; and

WHEREAS, the County Executive has determined that this property is not needed for government purposes and that the proposed Rails to Trails Program is a recreational use that will foster physical fitness and tourism within Cecil County, Maryland.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the County Executive, or his designee, is hereby authorized to execute on behalf of the County the Agreement of Sale with the Town of Rising Sun conveying the real property more fully described in Appendix 2 in consideration for the payment of \$1.00 by the Town.

AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that this Resolution shall take effect on the date of its passage by the County Council of Cecil County, Maryland.
