West Cecil Health Center

John Ness from West Cecil Health Center introduced himself as the new chief executive officer and provided an overview of the community health center. He reviewed the center's services that are offered at three locations including Conowingo, Havre de Grace and Perryville. He explained that as a community health center, services are provided on a sliding fee scale for the public. Dentistry is offered at the Perryville and Conowingo locations.

Mandatory Sewer Hookups

Vice President Schneckenburger distributed a draft letter to the County Executive asking that mandatory connections to county sewer system be rescinded and that the administration should clarify where the public infrastructure will be implemented. The Council agreed to discuss the letter at the following Council work session.

Council Manager Report

Mr. Massey updated Council Members about upcoming meetings and events. He suggested that the Council may wish to send a letter of opposition on HR 3043 Hydropower Policy Modernization Act of 2017. After discussion, the Council agreed to send a letter opposing this legislation to our congressional representatives.

Vice President Schneckenburger asked about a meeting on September 6 that was being held by Gary Kelman from MDE. Mr. Massey stated that he would get more information about it and let the Council know.

Council Member Comments

Councilman Patchell commented on the memorandum of understanding between the Cecil County Public Schools and the Cecil County Department of Parks and Recreation. He also commented about the turf field being installed at Perryville High School.

Councilman Meffley commented on attending MACo and its benefits to elected officials. He also attended a meeting of the Sassafras Riverkeepers and Friends of the Bohemia River, and commented that the water quality has not changed since the Chesapeake Bay Restoration Fund was instituted.

Councilwoman Gregory commented on the valuable opportunity to attend the MACo conference and the variety of programs of interest to Cecil County. She also commented on the Governor's Summit on Opioid Addiction that she attended during the conference.

Vice President Schneckenburger will be attending the Economic Development Commission and commented on the hiring opportunities for over one thousand new jobs, which have been created by the new business openings. He commented on the CAFOs meeting to be held by MDE on Wednesday, September 6. He also will be attending the 9-11 Tribute in Chesapeake City.

Council President Bowlsbey commented on the value of attending the MACo conference and the useful information gathered. She will be attending the College Foundation' Little Black Dress event and Cecilton Lions Club Night at the Races event.
