# COUNTY COUNCIL OF CECIL COUNTY LEGISLATIVE SESSION MINUTES LSD 2017-24 December 19, 2017

#### **CALL TO ORDER**

The meeting of the County Council of Cecil County of December 19, 2017 was called to order by Council President Bowlsbey at 7:00 p.m. and opened with the Pledge of Allegiance.

#### **OPENING PRAYER**

Vice President Schneckenburger introduced Pastor Steve Dixon from Porter's Grove Baptist Church of Conowingo, who delivered the opening prayer.

#### **APPROVAL OF AGENDA**

On motion made by Vice President Schneckenburger, seconded by Councilman Meffley, moved to approve the legislative agenda of December 19, 2017. Motion was carried by a vote of 4 to 0. Councilwoman Gregory was absent.

The Council presented a proclamation to Joanne Richart Young, Agriculture Coordinator, Department of Economic Development, in recognition of her retirement.

## **PUBLIC HEARING**

# Resolution 57-2017 Roads - Renaming - Maggies Lane

A Resolution to rename an unnamed road "Maggies Lane", which is off of Jacob Tome Memorial Highway on the south side of Hunters Sale Barn in Port Deposit.

The Resolution was introduced on November 21, 2017, advertised on December 6, 2017 and December 13, 2017, and scheduled for public hearing on December 19, 2017.

Eric Sennstrom, Director of Land Use and Development Services, provided comments on the legislation. There were no Council questions or comments.

Council President Bowlsbey opened the public hearing on Bill No. 2017-21 for public comments. Maggie Creshkoff, 2068 Jacob Tome Highway, Port Deposit, commented in support of the legislation.

Council President Bowlsbey concluded the public hearing on Resolution No. 57-2017 and announced that final consideration of this legislation will be held on January 2, 2018.

#### **APPROVAL OF MINUTES**

Councilman Patchell participated in the "Shop with a Cop" program and praised the program for the gree experience and organization in helping needy children.

Councilman Meffley stated that he has been on the Council for a year and has gained a great deal of knowledge. He commented on receiving many invitations during the holidays. He also stated that he is working with Mayor Rob Alt to explore possible locations of a homeless shelter.

Council President Bowlsbey attended the Local Management Board and commented on her interview with the library board regarding their strategic plan. She thanked the audience for attending and wished everyone a Merry Christmas and Happy New Year.

Al Wein, Director of Administration, provided introductory comments. Rebecca Anderson, Budget Manager, provided additional financial details.

A Resolution to amend the Department of Economic Development's Revolving Loan Fund governing policies to change the name of the Fund to Cecil Catalyst, revise loan making authority, restructure the governing board, expand uses for which Fund loans can be used, and to provide a streamlined application process for "micro" loans.

#### Bill No. 2017-23 Bond Authorization - Mill Run Sewer Extension - USDA

**Synopsis:** An Act authorizing and empowering Cecil County, Maryland, from time to time, to borrow not more than Eight Million Seventy Thousand Dollars (\$8,070,000) for the purpose of financing the costs of the Mill Run Sewer Infrastructure Extension, and to effect such borrowing by the issuance and sale of its general obligation bond at private sale to the United States of America, acting by and through the United States Department of Agriculture, Rural Development; empowering the County Executive to execute and deliver an executive order prior to issuing the bond in order to fix, prescribe and determine the details of the bond and the issuance and sale thereof; empowering and directing the County to levy ad valorem taxes in rate and amount sufficient to provide funds for the payment of the maturing principal of and interest on the bond; exempting the bond from the provisions of Sections 19-205 and 19-206 of the Local Government Article of the Annotated Code of Maryland, or successor provision; providing that the County may issue and sell the bond as a bond the interest on which is not excludable from gross income for federal income tax purposes; and relating generally to the issuance and sale of such bond.

The Bill was introduced on November 7, 2017 and public hearing held on December 5, 2017.

There were no Council comments or questions about this legislation.
