2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2018; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2018; and,
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 15, 2017, the
6	Budget for Cecil County was adopted for Fiscal Year 2018; and
7	WHEREAS, the County Executive is revising the Fiscal year 2018 revenue estimate for Cecil County
8	to increase use of Fund Balance available by \$400,000 to allow the following appropriation within the
9	General Fund:
10	a.) The addition of \$400,000 (\$325,000 snow removal, \$50,000 overtime, \$25,000 Motor Vehicle)
11	in expenditures for the Road's Maintenance snow removal budget to protect County citizens
12	traveling County maintained roads; and
13	WHEREAS, such appropriation is necessary to provide \$400,000 of fund balance for the General
14	Fund for expenditures.
15	NOW THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that
16	the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for Fiscal Year 2018 is hereby
17	amended for the supplemental appropriation, and by amending the Current Budget to appropriate
18	\$400,000 of additional expenditures in the General Fund to the Roads Maintenance Department's budget.
