3	program of control and eradication of noxious weeds; and
4	WHEREAS, Pursuant to a Memorandum of Understanding between the Maryland Department of
5	Agriculture and Cecil County, which was approved by the Cecil County Board of Commissioners on March
6	16, 2010, the Cecil County Board of County Commissioners agreed to appoint a Weed Advisory
7	Committee to assist the Department of Agriculture in developing and implementing a Noxious Weed
8	Control Program; and
9	WHEREAS, the Weed Advisory Committee of Cecil County works with the Roads Division of the
10	Department of Public Works in providing oversight for the weed control program, and
11	WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
12	Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;

14	WHEREAS, the County Executive has reappointed Monty Johnson, Anthony Calao, William Ewing,
15	Dave Hollenbaugh, Charles Robinson, Mike Scheeler, Dan Webber and Lane Heimer to the Weed Control
16	Advisory Committee for a one (1) year term, to expire March 15, 2019.
