WHEREAS, Pursuant to Maryland Annotated Code, Agriculture Article, Section 9-2402(4), the 1 Secretary of Agriculture may enter into agreements with any county or subdivision of the State to effect a 2 program of control and eradication of noxious weeds; and 3 WHEREAS, Pursuant to a Memorandum of Understanding between the Maryland Department of 4 Agriculture and Cecil County, which was approved by the Cecil County Board of Commissioners on March 5 16, 2010, the Cecil County Board of County Commissioners agreed to appoint a Weed Advisory 6 Committee to assist the Department of Agriculture in developing and implementing a Noxious Weed 7 Control Program; and 8 WHEREAS, the Weed Advisory Committee of Cecil County works with the Roads Division of the 9 Department of Public Works in providing oversight for the weed control program, and 10 WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County 11 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; 12 and 13 WHEREAS, the County Executive has reappointed Monty Johnson, Anthony Calao, William Ewing, 14 Dave Hollenbaugh, Charles Robinson, Mike Scheeler, Dan Webber and Lane Heimer to the Weed Control 15 Advisory Committee for a one (1) year term, to expire March 15, 2019. 16 NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, 17 that the reappointment of Monty Johnson, Anthony Calao, William Ewing, Dave Hollenbaugh, Charles 18 Robinson, Mike Scheeler, Dan Webber and Lane Heimer to the Weed Control Advisory Committee for a 19 one (1) year term, which will expire March 15, 2019, is hereby confirmed. 20 21 AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that this Resolution shall take effect on the date of its passage. 22 **INTRODUCED: February 6, 2018**
