Chapter 16, Article II, Section 16-7; and
WHEREAS, the Board of Parks and Recreation is authorized to determine all questions of general
policy relating to parks and public recreation in Cecil County, to supervise the expenditure of funds
appropriated to these purposes, and to keep the County informed as the availability of federal and state
funds for these purposes according to Chapter 16, Article II, Section 16-9 of the Code of Cecil County; and

WHEREAS, the Board of Parks and Recreation shall consist of eight members, one member being appointed by the Board of Education; and

WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; and

WHEREAS, the County Executive has reappointed Donald C. Harmer, Jr. to serve on the Board of Parks and Recreation for a three (3) year term which is to expire on February 20, 2021.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the reappointment of Donald C. Harmer, Jr. to the Board of Parks and Recreation for a three (3) year term, which is to expire on February 20, 2021, is hereby confirmed.
