WHEREAS, a portion of Brick Meeting House Road, shown in blue on the map attached hereto as
Exhibit A, binds on, is adjacent to, and bisects parcels of land owned by Cecil County, Maryland and more
commonly known as Calvert Regional Park (the "Park Property"); and
WHEREAS, the Cecil County Executive has requested that the County Council of Cecil County,
Maryland abandon that portion of Brick Meeting House Road shown in blue on Exhibit A; and,
WHEREAS, the owner of all land adjoining the red colored portion of Brick Meeting House Road
depicted in blue on Exhibit A is Cecil County, Maryland; and
WHEREAS, the portion of Brick Meeting House Road depicted as the blue area on Exhibit A is used
almost exclusively for the benefit of Cecil County, Maryland and, more specifically, Calvert Regional Park, its
employees, agents, and invitees; and
WHEREAS, the County Council has the authority, pursuant to Md. Code Ann., § 12-512, Local
Government Article, to open, alter, or close any public road or roads in Cecil County, Maryland; and
WHEREAS, the County Council has the authority, pursuant to Md. Code Ann., § 12-512, Local
Government Article, to sell or otherwise transfer real property when in their discretion it is no longer
needed for public use, and to authorize the execution and acknowledgement of any and all deeds and/or
other instruments necessary to effect and complete such a sale or transfer of real property; and
WHEREAS, the County Executive and the County Council find that the blue colored portion of Brick
Meeting House Road as depicted in blue on Exhibit A is no longer needed for use as a public street; and
WHEREAS, the County Executive and the County Council believe that it is in the best interest of the
County to abandon the blue colored portion of Brick Meeting House Road as depicted on Exhibit A and for
the abandoned roadway to become part of the Park Property; and
WHEREAS, the County has determined to approve the abandonment of that portion of Brick
Meeting House Road depicted in blue on Exhibit A hereto.
NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
MARYLAND, that the portion of Brick Meeting House Road that binds on and is adjacent to Calvert Regional
Park, such area of Brick Meeting House Road being more particularly shown as the blue colored area
identified on Exhibit A hereto is abandoned as a public road.
