INTRODUCED: February 20, 2018

WHEREAS, a local jurisdiction may establish by local law a planning commission with the powers and duties set forth in this division, pursuant to the Land Use Article of the Annotated Code of Maryland, Section 2-101; and

WHEREAS, the Cecil County Planning Commission was established and consists of six members plus an alternate who shall serve in the absence of a regular member; and a member of the County Council who serves as an ex-officio, non-voting member; pursuant to the Cecil County Zoning Ordinance, Section 295; Article XVI.; and

WHEREAS, each Planning Commission member serve three year terms and must be a resident of Cecil County; and

WHEREAS, the duties of the Planning Commission are to review, evaluate, and approve or disapprove plans for subdivisions in accordance with the Zoning Ordinance and Subdivision Regulations; and to review and make recommendations to the Cecil County Council regarding proposed changes or amendments to the Comprehensive Plan, Chesapeake Bay Critical Area Program, Zoning Ordinance, Subdivision regulations, Road Code, Master Water and Sewer Plan, acquisition and development of lands for open space or recreation purposes, historic sites or districts, land use or development arising from state or federal programs or policies, Forest Conservation Regulations; and to review the Capital Improvement Program annually; and to make recommendations to the Board of Appeals regarding applications for special exceptions; and

WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; and

WHEREAS, The County Executive has approved the appointment of Donald C. Harmer, Jr. to the Planning Commission term to expire March 6, 2021.

NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND confirms the appointment of Donald C. Harmer, Jr. to the Planning Commission; term to expire March 6, 2021.

AND, BE IT FURTHER RESOLVED that this Resolution shall take effect on the date of its passage by the County Council of Cecil County, Maryland.
