WHEREAS, pursuant to the Health - General Article of the Annotated Code of Maryland, Title 8 1 2 Substance Use Disorders Law, Subtitle 10 Local Drug and Alcohol Abuse Councils, each county shall have a 3 local drug and alcohol abuse council; and 4 WHEREAS, the local drug and alcohol abuse council (the "Council) shall consist of the following individuals: 5 6 1) The health officer of the local health department or their designee, 7 2) The director of the local department of social services or their designee, 8 3) The regional director of the department of juvenile services or their designee, 9 4) The regional director of the division of parole and probation or their designee, 5) The State's Attorney for the county or their designee, 10 6) The district public defender or their designee, 11 12 7) The county sheriff or their designee, 8) The president of the local board of education or their designee, 13 9) A representative of the county executive, 14 15 10) A representative of the county council, The county administrative judge of the circuit court or their designee, 16 11) 12) The administrative judge of the district court or their designee, 17 18 13) The following individuals appointed by the county executive, as appropriate: i) 19 At least one recipient of addictions treatment services; Two substance abuse providers, at least one of whom has experience with 20 ii) 21 services to individuals with co-occurring substance abuse and mental health disorders; 22 23 iii) At least one substance abuse prevention provider; 24 iv) At least one individual who is knowledgeable and active on substance abuse 25 issues that affect the county; 26 v) The superintendent, warden, or director of the local corrections facility; At least one other individual who is knowledgeable about treatment of 27 vi) substance abuse in the county, including members of civic organizations, the 28 chamber of commerce, health care professional organization or the clergy. 29
