Amendment – Master Water and Sewer Plan – Water Service Map – Town of Perryville

1 **WHEREAS**, the Environment Article of the Annotated Code of Maryland requires the County to have
2 a Master Water & Sewer Plan and provides for the administration, enforcement, and amendment of Plan;
3 and

4 **WHEREAS**, an amendment has been proposed to the Master Water & Sewer Plan, to amend the
5 water service area map for Perryville’s water service districts as indicated as Exhibit A; and

6 **WHEREAS**, Fire Station 16 of the Community Fire Company of Perryville is currently serviced by an
7 on-site well; and

8 **WHEREAS**, Fire Station 16 is located at 16 G.R. Dawson Drive, which is just outside the Town’s
9 corporation limits; and

10 **WHEREAS**, Fire Station 16 is currently shown on the Master Water and Sewer Plan as “Service
11 Provider to be determined”, and

12 **WHEREAS**, the existing well of Fire Station 16 is failing and the Community Fire Company of Perryville
13 has requested this change to allow the Town of Perryville to provide water to Fire Station 16; and

14 **WHEREAS**, the Department of Land Use and Development Services has recommended amendments
15 to the Master Water and Sewer Plan, Water Service Map for the Town of Perryville; and

16 **WHEREAS**, a public hearing was held on these proposed changes before the Planning Commission on
17 January 17, 2018; and

18 **WHEREAS**, the Planning Commission recommended approval of the proposed amendment.

19 **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**

20 **MARYLAND**, that the map amendment to the Master Water & Sewer Plan, Water Service Districts – Town of
21 Perryville, as indicated by Exhibit A, is hereby adopted.

22 **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this
23 map amendment shall be submitted to the Maryland Department of the Environment for its approval
24 pursuant to section 9-507 of the Environment Article of the Annotated Code of Maryland.

25 **AND, BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage.
