1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2017, the County
2	Executive submitted a proposed budget to the County Council for Fiscal Year 2018; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2018; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 15, 2017, the
6	Budget for Cecil County was adopted for Fiscal Year 2018; and
7	WHEREAS, the County Executive is revising the Fiscal Year 2018 Special Revenue – Other Grants
8	Fund revenue estimate for Cecil County to establish the following amount:
9	The addition of \$37,277 in grant revenue and expense to the Special Revenue – Other Grants
10	Fund operating budget to provide for the Maryland Department of Agriculture Grant award to
11	Cecil County Animal Services.
12	WHEREAS, such appropriation is necessary to provide \$37,277 of grant funding to provide free spay
13	and neuter to 572 pets – cats and dogs of residents of Elkton, North East, Perryville and Cecilton; this
14	project shall provide funds for essential surgical equipment for the shelter and free rabies vaccines shall
15	also be provided to each animal, if required; and the grant will allow the shelter to provide this service free
16	of charge to the pet owners who qualify for the service.
17	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
18	MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
19	Year 2018 is hereby amended for the supplemental appropriation; and by amending the Current Budget to
20	appropriate additional expenditures in the Other Grants Fund – Special Revenue - Animal Services to
21	record the grant of \$37,277 awarded by the Maryland Department of Agriculture.
